Architectural Prize of the Mayor of Warsaw

Residents' Vote

Regulations

§ 1 General Provisions

- 1. These regulations (hereinafter referred to as the 'Regulations') define the general conditions of the online vote accompanying the award of **the Architectural Prize of the Mayor of Warsaw** (hereinafter referred to as the 'Residents' Vote').
- 2. The Residents' Vote is organized by the City of Warsaw.
- 3. Any person taking part in the Residents' Vote (hereinafter referred to as 'Participant') agrees to follow the Regulations.
- § 2 Aim of the Residents' Vote
- 1. The Residents' Vote accompanies the competition for the Architectural Prize of the Mayor of Warsaw.
- 2. The aim of the Residents' Vote is to promote architectural projects completed in 2015, nominated for the Architectural Prize of the Mayor of Warsaw (hereinafter referred to as 'Architectural Projects').
- 3. 21 Architectural Projects divided into the following 6 categories are competing for votes within the framework of the Residents' Vote:
- a. Public service architecture public building
- b. Public service architecture commercial building
- c. Residential architecture housing development
- d. Residential architecture single building
- e. Revitalised architecture
- f. Public-access space.
- 2. Photographs and descriptions of the Architectural Projects available on the Residents' Vote website are purely for informative and reference purposes.
- 3. The result of the online vote shall be the final result of the Residents' Vote.
- 4. The results of the vote shall be announced during an official gala on 7 December 2016.
- 5. Information about the results shall be published on the website www.nagroda-architektoniczna.pl on 9 December 2016 at the latest.
- § 3 Rules of Participation in the Residents' Vote

- 1. Only those fulfilling the criteria specified below are eligible to take part in the Residents' Vote:
- a. Those casting a valid vote between 4 November and 24 November 2016 by filling out correctly the online voting form, i.e. selecting a single nomination among all the categories of Architectural Projects.
- b. Persons who are of legal age and have full legal capacity.
- c. Those who provide their name, last name and e-mail address in the online voting form.

The provision of personal data is voluntary and those who do so are entitled to access as well as to amend them.

- d. Those who accept the Regulations and consent to the collection and use of their personal data by the City of Warsaw Office and associate entities for the purposes of organizing the Residents' Vote, in accordance with the Law of 29 August 1997 on the Protection of Personal Data (JoL 2016, pos. 922).
- e. Correctly enter into the indicated field the code from a picture appearing on the website or indicate such pictures in accordance with the criteria specified.
- 2. A Participant may only take part in the Residents' Vote once.
- 3. A Participant can vote for only one of the 21 Architectural Projects.

§ 4. Committee

1. The Jury of the Prize shall ensure the smooth running of the Residents' Vote.

§ 5 Final Provisions

- 1. The Architectural Project obtaining the highest number of votes shall be considered the winner of the Resident's Vote.
- 2. The Organizer is not liable for:
- a. Problems with the running of the Residents' Vote, if these have occurred as a result of events that the Organizer, while exercising due care, could not have foreseen or prevented, particularly in case of emergencies and force majeure.
- b. Participation in the Residents' Vote in violation of the Regulations and any damages caused thereby.
- c. Any breaks in the functioning of the Residents' Vote caused by technical difficulties or reasons outside the Organizer's control.
- d. Failure to award the Prize pursuant to a Participant's provision of false personal data (email address).
- 3. The Organizer reserves the right to amend these Regulations in case of changes to the binding law or for any other important reason.

- 4. Participants' complaints with regard to the Residents' Vote shall be considered by the Organizer in written form within 30 days of receipt.
